



Our 2019 Achievements

Saving Critical Lands For Two Decades

Over the past year, the Flathead Lakers and Flathead Land Trust raised \$128,000 from private funds needed to qualify for a federal grant of \$500,000 from the Natural Resource Conservation Service. The funds allow us to protect key wetlands, floodplain, and farmlands along the Flathead River, just upstream from the lake, that help sustain our clean water and natural heritage.

With your support, the Flathead Lakers established and sustain the Flathead River to Lake Initiative, a diverse partnership that has conserved 6,000 acres of critical lands along rivers and wetlands upstream of Flathead Lake that help safeguard our clean water for 20 years.

Our 2019 Achievements

Educating Future Watershed Citizens

Over three days in May, the Flathead Lakers hosted 350 elementary students and 40 teachers and chaperones from 5 local schools for a day of hands-on learning about the beauty and complexities of our watershed.

Thank you to our 15 passionate volunteers inspiring the next generation of watershed citizens. Thank you to the Polson Rotary for their Festival of Youth grant to help update equipment and materials in our program.



Thwarting Aquatic Invasive Species (AIS)

Flathead Lake remains mussel free! With your support, the Flathead Lakers continued our 'Be a Montana Superhero' educational campaign, and community AIS education and outreach around the Flathead Valley.

We also helped bring AIS education to over 400 middle school students from 5 local schools, in partnership with the Flathead Lake Biological Station and the Confederated Salish and Kootenai Tribes.

We hosted five community mussel walks (and beach clean-ups) around the Flathead watershed. No mussels were found!

Citizen Scientists Monitor Record Clear Water

Flathead Lake citizen scientists recorded the clearest water in 25 years! Our team of 23 volunteers, and their kids, grandkids, friends, and neighbors, recorded over 60 Secchi disk observations around Flathead Lake this summer.

Thanks to your support and generous funding from the Greater Polson Community Foundation, we are growing community engagement and expanding our program.

Our citizen science program has already contributed to protecting our watershed. Data collected by our citizen scientists encouraged and supported the expansion of the Flathead Lake Monitoring Program (FMP) into Polson Bay.
